MULTI-SCALAR SPATIAL POLITICS AND URBAN GOVERNANCE IN EUROPE AND BEYOND

<u>Outline</u>

Cities and urban areas are contested spaces. They are spaces with powerful coalitions of interests, but also many voiceless and poor urban dwellers. Local politicians, city managers, residents, private entrepreneurs: whose interests determine and stimulate place making and how our cities transform? Who makes our cities, who 'owns' them, who governs them? In other words, what are the multi-scalar spatial politics and governance processes around these processes - particularly in times of increased social and ethnic diversities and translocal processes?

This seminar deals with cities in the so-called global South and North, their actors, their practices and motivations, their contexts, networks, and strategies, as well as with the underlying processes and the regulating instruments (institutions) that determine decisions in cities on a range of issues: housing, migration, urban social life, development, social and technical infrastructure, but also their histories and their service provision.

In this context, the seminar explores different central themes. First, it examines the social life of cities in terms of past and present migration phases and increased diversities. Who makes a city and for whom and why? We will review urban and integration policies as well as more bottom-up self-made modes of urban and social transformation. Second, the seminar then reviews urban governance concepts and theories that explain and offer models how different actors come together in managing common affairs and fuse their resources in cities. This also includes multi-scalar administrative and institutional aspects of local self-governance and the re-distribution of political and fiscal authority between levels of government and between government, the private sector and residents and their organized interest groups.

Further, the seminar introduces a range of key concepts and different approaches relevant for contemporary urban social life, governance and the analysis of spatial politics in metropoles with eventually very different urbanization patterns and trends. These include concepts of and approaches to diversity, migration and the city, social and ethnic segregation and their governance, informality, and comparative urbanism. The seminar offers the possibility to critically reflect on the origins of such concepts and their applicability across contexts of the global South and North – in and beyond Europe.

In addition, the seminar will zoom in on concepts and strategies of participation as well as their prerequisites (such as *social capital*) aiming to involve residents and promote

'governance from below'. It also introduces as a practical example the framework for social capital in strategies of area-based initiatives in Europe.

The seminar combines literature-based lectures on theoretic approaches on these themes with practical case experiences and examples in metropolitan areas across all world regions, comparing them to contemporary urban developments in Europe. Throughout the seminar, participants actively engage in testing the practical relevance and applicability of concepts by applying them to cities and concrete examples they are interested in or have lived in before.

05 Visualizing Narrative Spaces

Digital lecture, zoom link will be shared

In her audio-visual presentation, the artist Simone Rueß presents a selection of her works in which she explores aspects of urban structures (Movement Space), living and home-making (INhabit) and biographical narratives (Space/ Biography) in drawings, animations, objects and installations.

The focus of the lecture will be the project FRAGILE REMEMBERING, in which Rueß worked with narrativebiographical material through visualization techniques. She will present methods with which she approaches the spatial images of people with dementia. This shows not only how she visually analyses the history of the conversation. On the basis of her material, Rueß also explores how geopolitical caesures are inscripted into biographical narratives and shows with her artistic research surprising references to individual works of the CRC 1265.
